#### CALL TO ORDER

Chair Malek called the meeting to order with roll call.

10:04:40	Chair Malek opened the discussion on the NorthWestern Electric Rate Case with a brief outline of the case and the introduction of both members of the panel prior to their presentation .	
10:12:18	Robert A. Nelson, Consumer Counsel ( <u>Attachment 4</u> )	
10:18:35	Rep. Dunwell inquired as to why NorthWestern wanted to bifurcate the filing as referenced in Mr. Nelson's presentation.	
	Mr. Nelson outlined why historically costs were separated out.	
10:23:55	Rep. Dunwell referenced an email received from a consumer regarding the NorthWestern Rate Case and the NorthWestern Energy Resource Procurement Plan. Rep. Dunwell noted that the email asked that the Consumer Counsel ensure that the residential rate payers do not have an unfair burden of payment when reviewing these cases.	
10:25:14	Mr. Nelson continued with his presentation – bottom of page 1 – NorthWestern proposes a new rate class for new net metering customers.	
10:55:36	Rep. Dunwell inquired about the variations in the rate increases for the different rate classes.	

Mr. Nelson addressed cost allocation and how classes were treated differently during his presentation.

- 11:44:43 Senator Malek called the meeting back to order with a discussion on the future of Colstrip 4 and what that would mean to ratepayers.
- 11:55:33 Chair Malek inquired about the large customer rates and what could be done in high demand times to lessen the load on the grid by these companies. Mr. Nelson noted in response that the Commission would be looking at demand response programs in the near future.
- 12:00:40 Chair Malek expressed her concern that the Public Service Commission should not be able to conduct discovery in a particular case as referenced in Mr. Nelson's presentation. Concerning the discovery dispute, Mr. Nelson noted that whether the Commission should function more in a judicial versus a legislative role has been a topic of interest to ETIC.
- 12:06:00 Chair Malek referenced an email Mr. Nelson sent to the committee regarding Qualifying Facilities (QF) cases that are before the Montana Supreme Court that included an issue based on an off the record comment by a Commissioner. Chair Malek asked if that was something Mr. Nelson could talk to the Committee about publicly. Mr. Nelson summarized the QF appeals referenced.
- 12:08:59 Chair Malek asked Ms. Harbine if she could talk about decoupling. Ms. Harbine briefly outlined the basic concept of decoupling.
- 12:11:38 Chair Malek referenced a conversation with a representative from the Bonneville Power Administration (BPA) regarding the potential participation of NorthWestern and BPA in an energy imbalance market. Chair Malek asked Mr. Nelson if he was familiar with this discussion.

Mr. Nelson noted that Larry Nordell, MCC's part time Economist, has been involved with those discussions.

Mr. Stamatson stated that the Northern Tier Transmission Grid is in merger discussions with the Columbia Grid. Mr. Stamatson also noted that this is an exercise in planning to comply with FERC Order 1000.

12:14:30 Chair Malek expressed her concern about the cost of transmission and the risks associated with natural gas plants. Chair Malek also noted that she would like to see energy in the form of wind development in Montana.

Public comment None

12.20.39 Rep. Dunwell inquired about how the NorthWestern Energy Electricity Resource Procurement Plan integrates with the rate case moving forward.

	Ms. Harbine noted that both cases are related. Ms. Harbine also noted that NorthWestern's assumption is that Colstrip will operate until 2042 and that if Colstrip is so critical to NorthWestern's portfolio then it should have a plan B for addressing if that critical resource is removed. Mr. Nelson summarized the difference between the rate case and the procurement plan.
12:25:40	Chair Malek noted that during the 2019 Legislative Session there was intense pressure on Legislators to approve NorthWestern Energy buying an additional 20 percent of Colstrip 4 for one dollar. Chair Malek inquired about the risk this purchase would pass to the Montana ratepayers. Ms. Harbine stated that Commission oversight is critical as it acts as a substitute for competition in the context of a monopoly utility. Mr. Nelson summarized that without the Commission process questions raised regarding the addition acquisition of Colstrip assets would not be addressed in detail.
12:30:20	Rep. Dunwell inquired as to whether it is possible, without our knowledge, that NorthWestern is negotiating with the other owners of Colstrip, or plans to negotiate with other owners of Colstrip to acquire additional interests in Colstrip. Rep. Dunwell noted for the record that the NorthWestern Energy representative at the meeting was not at liberty to address her questions but that David Hoffman of NorthWestern would respond at a later time.
12:32:09	Jenny Harbine noted that Mr. Fadie pointed out in the Committee's September meeting that NorthWestern had not modeled a scenario in which it acquired additional Colstrip

Dunwell stated that because Colstrip has not been modeled does not mean it will not happen.</li> <li>Ms. Harbine agreed that because a scenario was not modelled does not mean that NorthWestern could not move forward and acquire additional interest in Colstrip.</li> <li>Ms. Harbine also noted that in order to recover costs of that acquisition from its ratepayers NorthWestern would be subject to post hoc scrutiny by the Commission.</li> <li>Rep.
