If the adoption of the adverse committee motion passes, the adverse committee report is adopted and the bill does not progress to 2 <sup>nd</sup> reading. If the motion to adopt the adverse committee report on the bill fails, the bill is placed on 2 <sup>nd</sup> reading in the committee of the whole. The motion to adopt a committee report is not debatable, but Senate Sponsor of the bill may respond to motion to adopt the committee report. If the Sponsor wants the bill to be placed on 2 <sup>nd</sup> reading, the Sponsor should explain why the body should vote against adopting the adverse committee report. In the House, if the motion is to reject the adverse committee report, it takes 3/5 vote to approve the motion. If the rejection motion passes, the bill is placed on 2 <sup>nd</sup> reading.
