SUBJECT: Request to be on the Legislative Council Agenda to request permission to sell the Sidney Armory to Richland County.

The Department of Military affairs (DMA) has an Armory located in Sidney, MT. We are no longer have a use for the old facility and have been approached by Richland County to purchase the facility. The appraisal value of the Sidney Armory is \$670,000. Richland County has agreed to purchase the facility. DMA's intent is to go to the Land Board in July to make the request to sell the Sidney Armory to Richland County.

What Lands are involved?

The Sidney Armory is located in Sidney Montana. The Armory sits on 1.68 acres, includes a 7154 SF Armory Building and three storage or out buildings.

Are there restrictions on the transfer?

Yes, Richland County is a Public entity under MCA 77-2-351, the property at transfer will be deed restricted with a binding commitment to use the property to provide a community service or benefit that fulfills a public service.

Are the terms of the transfer in the best interest of the State?

Terms of the transfer: Richland County will purchase the property for \$670,000. and will utilize the space as part of its Richland County public works shops. This use is a public purpose.

Is the manner of the transfer in accordance with public policy?

Yes the transfer is in accordance with public policy.

DMA's intent is to go to the Land Board in July to make the request to sell the Sidney Armory to Richland County. The Buy Sell agreement is currently being drafted and the closing date will be schedule 60 days after Land Board approval. Enclosed for your review are: Deed to the property, Plat of the Armory Site, aerial site location map and picture of facility. Please let me know the time and location of the meeting and I will be there to answer any questions you may have.

Know all men by these presents that the County of Richland, a municipal corporation and political Subdivision of the State of Montana, organized and existing under the laws of the State of Montana, in consideration of the sum of One and no/100 (\$1.00 ovc) Dollar the receipt of which is hereby acknowledged, does hereby grant, bargain, sell, convey and confirm unto the State of Montana the following described real property situate in the County of Richland, State of Montana, to-wit:

A parcel of land, being a portion of the Northwest Quarter of the Northwest Quarter (NW\frac{1}{4}NW\frac{1}{4}) of Section Thirty-two (32), Township Twenty-three (23) North, Range Fifty-nine (59) East, M.P.M. situate in Richland County, Montana, and more particularly described as follows, to-wit:

Beginning at a point which lies thirty (30) feet South and ten (10) feet East of the Northwest corner of said Section Thirty-two (32), Township Twenty-three (23) North, Range Fifty-nine (59) East, thence South along the right-of-way of County road for Three Hundred Twenty-five feet (325'), thence South 89°.56' East for Two Hundred Twenty-five feet (225'), thence North for Three Hundred Twenty-five feet (325'), thence North 89°.56' West for Two Hundred Twenty-five feet (225') to the point or place of beginning, containing 1.68 acres, be the same more or less.

Together with all and singular the tenements, hereditaments and appurtenances thereto belonging or in anywise appertaining conditional however, that the premises above described are hereby conveyed solely as site for a National Guard Armory and that if the grantee shall not, within five (5) years from the date of this deed, erect on said land a building for use as a National Guard Armory, the title to said premises shall, on the expiration of said period, revert to and become revested in the grantor.


