## AFW-12 Comments Recommendation 49 Enhanced solid waste recovery and recycling

The economic impacts of any legislation must be determined and be a part of the decision.

the technology should be able to stand on its own without a government handout. Free market should drive these programs.

How about curbside recycling? More people would be inclined to recyle if they had this available. Also, higher taxes on waste removal (i.e. weight per household).

These efforts are hypocritical. I would support these efforts only if ALL recycling was treated the same. The tax incentives should apply across the board to tires as well as other products.

There should be a cost/benefit analysis required. The benefits do not justify the costs using sound science. More taxes, regulations and red tape is not what will help Montana.

The lead for economic development should be at the local rather than state level. Sewage treatment in local communities is an important issue, regardless of waste to energy considerations. Scale is a problem for waste to energy production.

Pasma technology for landfills, Co-generation at Wastewater Facilities.

This must ensure that the tradeoff does not become one of lower carbon emissions but higher hazardous air pollutant emissions. Incentives for recovery and recycling should not result in increased air pollution.

Recyculing many times uses more energy than is saved. The feel good terminology sounds good to people but the reality of using more energy to recycle should be disclosed on those products. I feel that the packaging of products would be a better issue to address. Take for enstance a 5 quart oil change that leaves 5 plastic containers that breakdown in our landfills at a very slow rate. The amount of material used in electronicspackaging at times is more than the device being purchased. Sometimes we can't see the forest because of the trees.

As a member of our county's Solid Waste Board I have personally seen the financial benefits of recycling. And we aren't filling up the landfills as fast as we otherwise would.

When the cost of replacing the landfill skyrockets, we'll be glad we reduced the amount going to the dump.

More recycling programs, especially glass and plastics
