## **Medicaid Expansion**

Montana Legislature sets the Medicaid payment rates

Since January 1, 2016 when Montana allowed Medicaid Expansion we have seen a 158% increase in Medicaid flights (6.2 flights per month to 16 flights per month) (Jan-Mar) Self pay used to be at 7% is now 5.25% We have seen a decrease in Indian Health Services since January 1, 2016 of 54% (8.8 flights per month to 4 flights per month) (Jan-Mar) – I.H.S. is moving their members to Medicaid.
