At the meeting on March 12th Senator Hoven asked, just what help if any has the Richland County Commissioners provided too the city of Sidney? Jessica Redfield, Sidney's city clerk, stated infrastructure funded didn't help the spending part of their budget.

As you all are aware it is not legal according to state law for a county to give money to a city budget, we can only help fund projects. As commissioner we offered to loan the city of Sidney money at a very low interest rate, so they could build their new sewer lagoon without having to go through all the loops and hoops, extra money and time to apply for grants or loans from the state.

With the help of our Clerk and Recorder the commissioners were able to pull a few numbers together. However, before we get into the numbers please realize these are not all the numbers just major figures.

I would like to address some of the extra revenue that Sidney is currently receiving because the county commissioners thought funding these projects was a wise investment. Here are a few examples; The county paid \$1,699,384.00 for the Dry Red Water expansion Sidney South Pipeline. To date Sidney has collected from DRW \$349,209.00. The city will continue to earn income from this venture from the customers that were able to build south of Sidney.

In the past five (5) years the Justice Court has collected \$2,393,000.00 in fines and forfeitures, of which Sidney has received \$1,087,647.00. During this same period the city of Sidney has paid to the county \$180,00.00 for attorney wages, while the county has paid over \$2,320,000.00. Nice money maker don't you think?

The new \$7.9 million fire hall replaced the old fire hall that is now being utilized by the city for much needed shop space. But here is the thing, while the old fire hall was in use there wasn't a water bill paid to the city. The new fire hall that the county built is required to pay \$15,600 annual for city water. Sounds like there is some extra income.

I know this sounds nitpicky, but it is frustrating when you think you are helping and hear things like this.

A few projects funded with oil and gas monies from Richland County invested directly into the city of Sidney.

There are several other things we could discuss but I am sure you all can see the Richland County Commissioners are not hording our meager share of the oil and gas revenue. If the formula is change that reduces our share instead of increasing it, like it should be, Sidney will not benefit as well as they have. As county commissioners we can only share what we have.
