## **SUMMARY OF RULE(S):**

The Public Employees' Retirement Board proposes to amend two rules. The proposed amendments update current rules that adopt by reference the State of Montana 401(a) Defined Contribution Plan Investment Policy Statement and the State of Montana 457 Plan (Deferred Compensation) Investment Policy Statement from previous versions to versions approved on February 8, 2018.

The previous policy applied to the investment options of both plans, but the Board's investment consultant, advisory committee, and policy committee recommended that the policy be replicated in the Board's Statement of Montana Investment Policy Statement 401(a) Defined Contribution Retirement Plan (Policy No. BOARD Admin 11) and the State of Montana Investment Policy Statement 457(b) Deferred Compensation Plan (Policy No. BOARD Admin 12), respectively, rather than containing them in a separate policy.

Beyond minor stylistic changes, the deletion of extraneous or repetitive information, and edits for reorganizational purposes, no substantive changes appear to have been made by eliminating BOARD Admin 08 and moving its contents to BOARD Admin 11 and 12.

**NOTES:** A public hearing is not anticipated. The public comment period ends on March 23, 2018.
