(1) A person commits the offense of theft when the person purposely or knowingly 13 obtains or exerts unauthorized control over property of the owner and: 14 (a) has the purpose of depriving the owner of the property; 15 (b) purposely or knowingly uses, conceals, or abandons the property in a manner that deprives the 16 owner of the property; or 17 (c) uses, conceals, or abandons the property knowing that the use, concealment, or abandonment 18 probably will deprive the owner of the property. 19 (2) A person commits the offense of theft when the person purposely or knowingly obtains by threat or 20 deception control over property of the owner and: 21 (a) has the purpose of depriving the owner of the property; 22 (b) purposely or knowingly uses, conceals, or abandons the property in a manner that deprives the 23 owner of the property; or 24 (c) uses, conceals, or abandons the property knowing that the use, concealment, or abandonment 25 probably will deprive the owner of the property. 26 (3) A person commits the offense of theft when the person purposely or knowingly obtains control 27 over stolen property knowing the property to have been stolen by another and: 28 (a) has the purpose of depriving the owner of the property;

(7) (a) Except as provided in subsections (7)(b). (7)(d). and (7)(ed), a person convicted of a first 21 22 offense of the offense of theft of property not exceeding \$1,500 in value shall be fined an amount not to exceed 23 \$500. A person convicted of a second offense shall be fined an amount not to exceed \$500 or be imprisoned in 24 the county jail for a term not to exceed 6 months, or both. A person convicted of a third or subsequent offense 25 shall be fined an amount not to exceed \$500 and be imprisoned in the county jail for a term of not less than 5 26 days or more than 1 year.

(b) (i) Except as provided in subsections (7)(c) and (7)(e), a person convicted of the offense of theft

of property that exceeds \$1,500 in value and does not exceed \$5,000 in value shall be fined an amount not to

exceed \$1,500 or be imprisoned in the state prison for a term not to exceed 3 years, or both. A person convicted of a second offense shall be fined an amount not to exceed \$1,500 or be imprisoned in the state prison for a term not to exceed 5 years, or both. A person convicted of a third or subsequent offense shall be imprisoned in the state prison for a term of not less than 2 years or more than 5 years and may be fined an amount not to exceed \$5,000.

- (ii) A person convicted of the theft of property exceeding \$5,000 in value or as part of a common scheme as defined in 45-2-101, or the theft of any amount of anhydrous ammonia for the purpose of manufacturing dangerous drugs, shall be fined an amount not to exceed \$10,000 or be imprisoned in a state prison for a term not to exceed 10 years, or both.
- (iii) A person convicted of the theft of any commonly domesticated hoofed animal shall be fined an amount of not less than \$5,000 or more than \$50,000 or be imprisoned in a state prison for a term not to exceed 10 years, or both. If a prison term is deferred, the court shall order the offender to perform 416 hours of community service during a 1-year period, in the offender's county of residence. In addition to the fine and imprisonment, the offender's property is subject to criminal forfeiture pursuant to 45-6-328 and 45-6-329.
- (c) A person convicted of the offense of theft of property exceeding \$10,000 in value by embezzlement shall be imprisoned in a state prison for a term of not less than 1 year or more than 10 years and may be fined an amount not to exceed \$50,000. The court may, in its discretion, place the person on probation with the requirement that restitution be made under terms set by the court. If the terms are not met, the required prison term may be ordered.
- (d) A person convicted of a first offense for the offense of theft of property not exceeding \$1,500 in value and who utilized an emergency exit in furtherance of that offense shall be fined an amount not to exceed \$500 or be imprisoned in the county jail for a term not to exceed 6 months, or both. On a second conviction, the offender shall be fined an amount not to exceed \$1,000 or be imprisoned in the county jail for a term not to exceed 1 year, or both. On a third conviction, the offender shall be fined an amount not to exceed \$5,000 and be imprisoned in the county jail for a term of not less than 5 days or more than 1 year.
- (e) A person convicted of the offense of theft of property of a motor vehicle of any value shall be imprisoned in a state prison for a term of not less than X year or more than X years.
